As co-host of the global Girl Summit in London, you took the lead in creating an ‘international charter’ to enlist support from nations where abuses of young girls are most severe — a task more necessary than ever.”

I urge you to take stronger action on behalf of **all children** that are subjected to genital mutilation where, as Head of State, you could petition the World Court, The Hague, to affirm that the genital Mutilation of children is *de facto* violation of **Article 5** of the **Universal Declaration of Human Rights**; and **Article 37** of the **U.N. CONVENTION ON THE RIGHTS OF THE CHILD**.

This action was previously taken by the General Assembly of the *First International Symposium on Circumcision*, which passed unanimously the Resolution **The Universal Declaration on Circumcision, Excision, and Incision** (1989), enclosed and has led to a **PETITION TO THE WORLD COURT, THE HAGUE** and can be viewed at
